Agreement:

To be signed by student:

I, _____, a recipient of a fellowship and/or participant in the study abroad program sponsored by the International Design Clinic, Inc. (hereinafter referred to as "IDC"), agree to the following:

I waive any and all claims against IDC, Scott G. Shall and its/his agents or contractors, domestic and overseas, my local school, and any staff members accompanying the group, their heirs or their estate, arising from any death, injury, loss, damage, accident, delay, irregularity or expense to person or property incurred from the use of any vehicle or services, strikes, war, weather, sickness, quarantine, government restrictions or regulations, or arising from any act or omission of any steamship, airline, railroad, bus company, sightseeing, hotel or any other service or transporting company, firm, individual, or agency. I also release IDC, Scott G. Shall and its/his agents or contractors from any financial obligations or liabilities that I may incur as an individual, or any damage or injury to the person or property of others that I may cause while participating in this program, and I agree to indemnify them against any such financial obligations or liabilities.

Nothing in this form or release shall be interpreted as releasing IDC and/or Scott G. Shall from liability arising from its/his negligence, or that of its/his employees. I understand that the air carrier's liability for loss or damage to baggage, or for death or injury to person or property, is limited by their tariffs and/or by the Warsaw Convention. More specifically, the liability of the air carrier for loss, delay, or damage to baggage is limited. Carriers assume no liability for fragile or perishable articles. IDC and Scott G. Shall are not responsible for loss of, theft of, or damage to my belongings, including my passport.

I understand that IDC and Scott G. Shall are not responsible for my well-being during such periods of time that I may be absent from IDC activities, as during these times of independent travel, visits to friends and relatives and so forth.

I agree that any likenesses taken of me while participating in the IDC program and any of my comments or statements may be used in future materials published by IDC.

I agree and understand that any illegal activity on my part may result in imprisonment and/or deportation for a foreign country. I agree to accept any and all responsibility, whether legal and/or financial, as a result of any illegal act.

If I am not a citizen of the United States, I understand and accept that it is my personal responsibility to obtain all visas and required documents as a result of my not being a United States citizen in order to participate in the IDC program. Further, I shall hold IDC

and Scott G. Shall harmless in the case where I may not obtain the necessary documents for participation in the program. I understand that the inability to obtain these visas and other documents constitutes grounds for withdrawal of any fellowship or scholarship awarded by IDC.

Additionally, I consent to the exclusive jurisdiction of the courts of Lafayette Parish, Louisiana, in any action or proceeding hereunder, and irrevocably appoint any employee of IDC as agent for the undersigned for service of process conditioned that all papers served upon said agent be forwarded to the undersigned. No modification, renewal, extension or termination of this agreement shall affect said appointment and choice of forum.
